<b>1</b>	<p><b>Funding</b></p> <p><b>The Pilgrim Trust - Social Welfare Fund</b></p> <p>The Social Welfare Fund is for projects supporting people who misuse drugs or alcohol that fall within one, or both, of the following themes:</p> <ul style="list-style-type: none"> <li>• Projects to assist with the return or entry into education, training, volunteering or employment of people who have been or are misusing drugs or alcohol</li> <li>• Projects to support the families and/or carers of people who have been or are misusing drugs or alcohol</li> </ul> <p>The Trust may also be able to fund projects in prisons and projects providing alternatives to custody. Trustees have a particular interest in projects that assist prisoners to acquire new skills or give support to their families.</p> <p>The Pilgrim Trust will consider applications for revenue costs such as staff salaries but generally not equipment costs. They may also consider project and capital costs.</p> <p><b>The Trust will not consider:</b></p> <ul style="list-style-type: none"> <li>• Arts and drama projects - unless they can demonstrate that they are linked to clear educational goals for prisoners or those with drug or alcohol problems</li> <li>• Youth or sports clubs, travel or adventure projects, community centres or children's play groups</li> <li>• One-off events such as exhibitions, festivals, seminars, conferences or theatrical and musical productions</li> </ul> <p><b>Grant size</b></p> <p>The Pilgrim Trust gave away approximately £2 million in 2008. The average size of grant was £23,500 but nearly half of the grants were for £20,000 and under.</p>

<p><b>2</b></p>	<p><b>The Peter Harrison Foundation</b></p> <p>The Peter Harrison Foundation offer grants under the "Opportunities through Sport" programme. The Foundation's Trustees wish to support sporting activities or projects which provide opportunities for people who are disabled or otherwise disadvantaged to fulfil their potential and to develop other personal and life skills.</p> <p>Grants will often be "one off" grants for capital projects. The Funder may also consider revenue funding for a new project or if funding is key to the continuing success or survival of an established project.</p> <p><b>Applications for the following types of project are welcomed:</b></p> <ul style="list-style-type: none"> <li>• Projects which provide a focus for skills development and confidence building through the medium of sport</li> <li>• Projects that have a strong training and/or educational theme within the sporting activity</li> <li>• Projects that provide sporting equipment or facilities for disabled or disadvantaged people</li> <li>• Projects with a high degree of community involvement</li> <li>• Projects that help to engage children or young people at risk of crime, truancy or addiction</li> </ul> <p><b>The Foundation only accepts applications from organisations that are:</b></p> <ul style="list-style-type: none"> <li>• Registered Charities</li> <li>• Community Amateur Sports Clubs</li> <li>• Friendly Societies or Industrial Provident Societies</li> </ul> <p><b>Application process:</b></p> <p>The Peter Harrison Foundation operates a two-stage application process. Step 1 is the <a href="#">Initial Enquiry</a> - to check whether your project might be of interest to the Peter Harrison Foundation. If successful, you can then proceed to making a full application. <p><b>3</b></p>	<p><b>02 It's Your Community</b></p> <p>The aim of <b>It's Your Community</b> is to connect young people into their communities. The <b>02 It's Your Community</b> awards will only consider community based applications up until the end of December 2009. After that date, they will be increasing the youth focus of their awards.</p> <p><b>Projects should be:</b></p> <ul style="list-style-type: none"> <li>• Youth focused (11-25 years of age)</li> <li>• Sustainable (it will keep going once this money is spent)</li> <li>• Non-political and non-religious</li> <li>• Based in the UK</li> <li>• On public or accessible land</li> <li>• Ready to go (Awards are granted every month, so apply when you are set to spend)</li> <li>• Small enough that £1000 will make all the difference</li> </ul> <p><b>The Fund cannot help with:</b></p> <ul style="list-style-type: none"> <li>• One off events or workshops</li> <li>• Fundraising activities</li> <li>• School projects that don't involve the wider community</li> </ul> <p><b>How to apply</b></p> <p>Log-in to the "Get Your application in today" section at the bottom of the <a href="#">"Apply for an Award"</a> link. <a href="http://www.itsyourcommunity.co.uk">www.itsyourcommunity.co.uk</a></p>

<p><b>4</b></p>	<p><b>J Paul Getty Jnr Charitable Trust</b></p> <p>The Trust's main aim has always been to fund well managed projects which help to relieve poverty, support disadvantaged people, and effect long-term change where help is not readily available from the public or private purse.</p> <p>The Fund's trustees have decided to wind down the Trust over a period of between five and ten years. This means that they will be increasing the level of annual spend and will be looking for opportunities to award a number of more substantial grants that will have an enduring impact.</p> <p>Main grants can be between £10,000 and £250,000 over a period of 1 to 3 years. Small grants of up to £5,000 are also available for smaller charities. Applications are made in exactly the same way as for the main grants programme.</p> <p><b>The Fund is currently inviting applications from registered charities in the following areas:</b></p> <ul style="list-style-type: none"> <li>• Reducing Reoffending: projects aiming to improve the lot of people in prison and smooth the transition for those leaving prison, maximising their chances of successful resettlement</li> <li>• Improving Prospects: projects providing meaningful occupation for young people aged 14-19 to improve their employability and diminish the risk of social exclusion; work to improve the treatment of refugees and asylum seekers</li> <li>• Repairing Communities: projects led from within the community with the aim of integrating different social and ethnic groups in pursuit of worthwhile goals</li> <li>• Repairing Lives: projects making a lasting impact on the lives of people with substance misuse problems; projects helping people who are homeless or at risk of homelessness</li> </ul> <p>Applications must be made <a href="#">online</a>.</p>
<p><b>5</b></p>	<p><b>UnLtd 4iP Awards</b></p> <p>UnLtd and 4iP have teamed up to help individuals develop early stage digital media ideas and prototypes. <p><b>6</b></p>	<p><b>Vetting and Barring Scheme safeguards introduced</b></p> <p>On 12 October, increased safeguards for children and vulnerable adults were introduced under the Vetting and Barring Scheme (VBS). It is now a criminal offence for individuals barred by the ISA to work or apply to work with children or vulnerable adults in a wide range of posts - including most NHS jobs, Prison Service, education and childcare. The new ISA barred lists replace the three former barred lists (POCA, POVA and List 99).</p> <p>ISA-registration for the Vetting and Barring Scheme <b>does not start for new workers or those moving jobs until July 2010</b> and ISA-registration does not become mandatory for these workers until November 2010. All other staff will be phased into the scheme from 2011.</p> <p>CSAS will shortly be publishing a brief guide to the new scheme, specifically written for community</p>

7	<p><b>New guidelines update and outline ASBO reporting restrictions</b></p> <p>Guidelines on when reporting restrictions should or should not be imposed in criminal cases has been updated and published by leading industry bodies. The guidelines are aimed at judges, magistrates, journalists and lawyers, and take account of recent changes in the law. It includes reporting anti-social behaviour orders (Asbos).</p> <p>The new guidelines are available on the <a href="#">Judicial Studies Board</a> website.</p>
8	<p><b>Virtual Court pilots - defendants consent no longer required</b></p> <p>The Virtual Courts pilot scheme was announced in May 2009 and involves defendants having their cases heard at a magistrates' court, via secure video link from a police station, within hours of being charged. Virtual Courts are being used for 'first hearings'. If a defendant pleads guilty, sentencing could be handed down on the same day.</p> <p>Although originally requiring defendants' agreement to be dealt with by Virtual Courts, the law changes in November to remove the need for a defendant's consent.</p> <p>Click <a href="#">here</a> for more information on the virtual courts pilot.</p> <p>Click <a href="#">here</a> for more information on future developments for the magistrates courts service in London.</p>
9	<p><b>Home Office sets up young anti-knife crime campaigners task force</b></p> <p>A new group of 27 young campaigners aged between 15 and 20 with first hand experience of knife crime, will spread anti-knife crime messages to their peers in their communities and via the social networking site Bebo. As part of the <i>It Doesn't Have to Happen Campaign</i>, the Home Office has also launched a new set of adverts designed to turn young people away from knife crime. 10	<p><b>New Supreme Court opens October</b></p> <p>The Supreme Court has been established to achieve a complete separation between the United Kingdom's senior Judges and the Upper House of Parliament, emphasising the independence of the Law Lords and increasing the transparency between Parliament and the courts.</p> <p>The Supreme Court, as well as being the final court of appeal, will play an important role in the development of United Kingdom law. As an appeal court, The Supreme Court cannot consider a case unless a relevant order has been made in a lower court.</p> <p>The Supreme Court will:</p> <ul style="list-style-type: none"> <li>• be the final court of appeal for all United Kingdom civil cases, and criminal cases from England, Wales and Northern Ireland</li> <li>• hear appeals on arguable points of law of general public importance</li> <li>• concentrate on cases of the greatest public and constitutional importance</li> </ul> <p>Visit the new <a href="#">Supreme Court website</a> for more info.</p>

12	<p><b>Trident warning as more women stash guns</b></p>

	<p>Young women are being warned about the grave consequences of storing and transporting guns for others in a hard-hitting advertising campaign unveiled by Trident, the Metropolitan Police's anti-shooting unit, today (30 September 2009).</p> <p>Under the strap line "Hide his gun and you help commit the crime" the campaign features radio, cinema and billboard advertisements aimed at 15 to 19 year old young women of African and African Caribbean heritage.</p> <p>The campaign - which will target the six priority boroughs of Brent, Hackney, Haringey, Lambeth, Lewisham and Southwark - is a response to a recent rise in the number of young women being arrested and convicted for possessing weapons.</p>
13	<p><b>London Youth launches anti-gang project</b></p> <p>A new London Youth initiative 'Positive Change' aims to reduce offending, antisocial behaviour and engagement in gangs. Through youth clubs in Greenwich, Kensington &amp; Chelsea, Lambeth, Lewisham and Tower Hamlets, the programme will support at least 2,000 young people, who are at risk of or involved in gang-related activity, to take up positive activities, re-engage in education and secure training or employment over the next 18 months.</p> <p>Visit the <a href="#">London Youth website</a> for more info.</p>
14	<p><b>New report shows homophobia deters lesbian, gay and bisexual people from working with children</b></p> <p>A study by the Equality and Human Rights Commission (EHRC) has warned that lesbian, gay and bisexual (LGB) young people and staff still face high levels of homophobic bullying both inside and outside of school.</p> <p>Only 51 per cent of lesbians, 52 per cent of gay men, 44 per cent of bisexual women and 10 per cent of bisexual men felt they could be open about their sexual orientation in schools, colleges and universities, whilst many said they would avoid teaching or other jobs that involve working with children because of negative perceptions relating to their sexual orientation.</p> <p>The report, <a href="#">Beyond Tolerance: Making Sexual Orientation a Public Matter</a>, calls for LGB issues to be included in the national curriculum, support for LGB pupils and staff and a zero tolerance approach to homophobic bullying.</p>
15	<p><b>Local Crime Community Sentence FREE Presentations</b></p> <p>'To improve public confidence in sentencing and to raise awareness of the effectiveness of community sentences'.</p> <p>Local magistrates and probation workers are teaming up to go out and deliver interactive, case study based presentations to communities groups within London. These presentations are aimed at addressing issues relating to crime and punishment, and invite audiences to share their views on crime.</p> <p>We welcome you to participate in this initiative which is run by London Probation and the Magistrates Association, which will give you the opportunity to decide what you would do if you were on the bench.
